#### **Tax Credits For Non-public** Schools

#### Website empowerillinois.org

The State of Illinois passed a comprehensive education funding bill this past August 2017 that was signed into law. The law includes a provision for tax credit wghIgbNDF1C dFk MB0xGiZ scholarships—a 75% income tax credit to individuals and busi-

nesses-supporting non-public school scholarships for lowincome students in the state. Illinois students from lowincome families may use these new scholarships to attend a nonpublic school of their choice. \* Donors must apply for the credit via an application process that opens at midnight January 2, -GSLS Change Drive 2018; credits are issued on a first come, first served basis.

\* Individual donors can designate that their donation be used to support scholarships at a specific school.

Students arriving late to school must have a tardy slip to enter the classroom after the bell has rung. When you sign in your child, the student will be given a tardy slip to take to the teacher. Arriving late due to an appointment, please bring an excuse from the doctor's or dentist's office.

#### Tardiness

School tardiness and absences can make a child fall behind. This can become a problem if the occurrence begins to becomes habitual.

So what is the impact of tardiness on school success? Students who are on time to school are more successful. Schools stress the need for students to get to school and class on time and with good reason. Studies conducted by the U.S.

Department of education on truancy, which is connected with tardiness, show that school attendance is a major factor when it comes to school and student behavior.

So what are the problems with tardiness? The most crucial learning hours of the school day are the morning hours, because they are when students are most attentive. Students who are tardy miss the beginning of their morning classes, and they also cause a distraction when they arrive late to class.

So how does this effect Academics and Achievement?

Students who are frequently tardy have lower GPAs, lower scores on standardized assessments, and lower graduation rates, Chronic tardiness in elementary and middle school is also linked to failure in high school.

It is our goal at GSLS to provide every child the opportunity to learn, but this becomes a problem when one is tardy or absent. We need to partner together so both parties see the importance. Questions are welcomed.

### **STUDENTS: HOW TO APPLY** FOR A TAX CREDIT SCHOLARSHIP

#### FAMILIES OF K-12 STUDENTS CAN APPLY FOR SCHOLARSHIPS BEGINNING JANUARY 24, 2018.

The Tax Credit Scholarship will cover up to 100% of private school tuition up to a maximum of the average Illinois cost to educate, which is roughly \$13,000.

Students with unique learning needs, including those who are gifted, English language learners, or those with special education qualifications, will receive larger scholarships — up to double— roughly 26,000.

Tax Credit Scholarships are need based and do not take academic performance into consideration.

#### **THE PROCESS**

- **01.** Families submit a complete application. See below for what an application requires.
- **02.** Families are notified of their application status.
- **03.** Students begin school admission and enrollment process.\*
- **04.** Scholarship award notifications are sent to families beginning in February and continue until available funds are used.
- **05.** Funds will be distributed to schools at the start of the 2018-2019 school year. Empower Illinois will work directly with schools and organizations to distribute funds.
  - The school admission process is separate from the scholarship process. A scholarship does not guarantee admittance.

A copy of your family's 2016 federal tax return. If the family did not file a 2016 tax return, please contact us at info@empowerillinois.org



Proof of Illinois residency, such as:

- Current utility bill
- Current driver license



Documentation of the student's age, such as:

- A copy of the student's birth certificate
- Federal or State ID
- A passport

If available, a letter of acceptance or enrollment at an eligible, participating, non-public school.

### **ABOUT THE** TAX CREDIT SCHOLARSHIP PROCRAM

#### INVEST IN KIDS ACT.

Illinois enacted the Invest In Kids Scholarship Tax Credit Program in 2017. This program offers a 75 percent income tax credit to individuals and businesses that contribute to qualified Scholarship Granting Organizations (SGOs). The SGOs then provide scholarships for students whose families meet the income requirements to attend qualified, non-public schools in Illinois.

#### TAX CREDIT SCHOLARSHIPS.

The Tax Credit Scholarship will cover up to 100% of private school tuition up to a maximum of the average Illinois cost to educate which is roughly \$13,000.

Students with unique learning needs, including those who are gifted, English language learners, or those with special education qualifications, will receive larger scholarships — up to double— roughly 26,000. Key information about the program and donating to these scholarships can be found below.

#### **EMPOWER ILLINOIS.**

Empower Illinois is an independent 501(c)(3) non-profit SGO responsible for serving approximately 80% of participating private schools statewide; including all of Illinois' Catholic Dioceses, most area Jewish schools, Lutheran Schools, secular schools and many more. Empower Illinois is responsible for:

- · Processing donations from individuals and corporations;
- · Accepting scholarship applications from students/families; and
- · Distributing scholarships to eligible students/families in accordance with the law.

#### TAX CREDITS.

Individual and corporate donors may receive a credit for their Illinois state taxes equal to 75 percent of donations to an SGO.

• A taxpayer donates \$10,000 to an SGO; they are eligible to claim a \$7,500 tax credit on their 2018 taxes.

Tax credits are capped at \$1 million per taxpayer per year; a donor can contribute about \$1.33 million to receive the maximum tax credit allowed. Donors cannot receive a federal deduction for gifts made through this program, but the net tax benefit to all donors is expected to be greater than ordinary charitable donations of an equal amount. Total tax credits are capped at \$75 million per year statewide, which equates to \$100 million in donations and scholarships. Please consult a tax professional to determine how such gifts will affect tax liability.

#### DESIGNATING DONATIONS.

Individuals may direct their donations to a particular school or subset of schools, but not to an individual student or group of students. Corporate donors cannot designate their donations to a particular school.

#### DONATION PROCESS.

Donors can begin the process by registering with mytax.illinois.gov. After the registration process, which can take up to 10 business days, donors will be ready to reserve their tax credit beginning January 2 on a first-come, first served basis. When reserving their tax credit, donors should select Empower Illinois as the Scholarship Granting Organization. Once their credit has been reserved, they have 60 days to make their donation to an SGO.

#### SCHOLARSHIP ELICIBILITY.

To be considered for a 2018-2019 scholarship, K-12 students must come from a household with income below 300 percent of the federal poverty level (\$73,800 for family of four). Prior to April 1, priority will be given to:

- · Students from households below 185 percent of the federal poverty level (\$45,510 for family of four)
- · Students who reside in a "focus district" (low-performing public schools)

#### Tax Credits for Donations to Non-Public Schools

The State of Illinois passed a comprehensive education funding bill this past August (2017) that was signed into law. The law includes a provision for tax credit scholarships -a 75% income tax credit to individuals and businesses - supporting non-public school scholarships for low-income students in the state. Illinois students from low-income families may use these new scholarships to attend a non-public school of their choice.

The basics of the program are as follows:

- Beginning in 2018, Illinois donor residents and corporations are eligible for a tax credit equal to 75% of donations make to a qualifying Scholarship Granting Organization (SGO), up to \$1 million.
- Donors must apply for the credit via an application process that opens at midnight on January 2, 2018; credits are issued on a first come, first served basis.
- Individual donors can designate that their donation be used to support scholarships at a specific school.
- Once approved for a tax credit, the donor must make their donation to the SGO within 60 days of their application date.

#### How Do I Make My Donation and Get My Credit?

Empower Illinois, a statewide Scholarship Granting Organization (SGO) was created in 2017 to serve Illinois children through the state's tax credit scholarship program. Empower Illinois connects Tax Credit Scholarship Donations to Illinois students whose education opportunities may be limited by household income.

- 1. Begin the process by registering/activating your account with www.mytax.illinois.gov.
- 2. An ID letter will arrive in the mail (can take up to 10 business days). Sign-up/activate your www.mytax.illinois.gov account.
- 3. Reserve your tax credit beginning January 2, 2018. The opportunity will be on a first-come, first served basis. You are encourage to reserve yours as soon as possible.
- 4. Once credit has been reserved, you have 60 days to make your donation Empower Illinois at www.EmpowerIllinois.org. Do not send your donation directly to the school.
- 5. Claim your tax credit when you file your 2018 Illinois State Taxes.

We encourage you to begin the process as soon as possible as donations can first be made starting January 2, 2018. If you know of a corporation which may be interested in this program, please notify your school leader.
